



To download the NOW YOU ARE 18 app:

- 3. Type "NOW YOU ARE 18" in the Search Bar. (You may have to click "Search" on some devices.)
- Click "Get" or "Open" or the iCloud icon beside the NOW YOU ARE 18 app. The app should download.




